1. This information is being furnished as a courtesy to you by the Justice Court, Precinct 1 of Randall County, Texas, to assist you in making disposition of the charge or charges filed against you.
2. IF YOU WISH TO ENTER A PLEA OF GUILTY OR NOLO CONTENDERE, please indicate below in the proper space provided. A plea of NOLO CONTENDERE means that you do not contest the state’s charge(s) against you. The fine of a NOLO plea is the same as that for a plea of Guilty. Either plea indicates that you agree to waive appearance before the Court for Trial.
3. You must refer to the schedule shown on the reverse side of this letter to determine the total amount of your fine(s) and costs assessed against you. Submit your payment to the Court designated on your citation by Cashier’s check or Money Order or by Credit Card on our website at [randallcounty.org](http://randallcounty.org).  
**(PERSONAL CHECKS WILL NOT BE ACCEPTED...DO NOT MAIL CASH)**
4. IF YOU WISH TO ENTER A PLEA **NOT GUILTY** and desire a trial, you must indicate in the space provided below. The Court will then set your case for the next available Docket Call.
5. A parent will need to accompany a minor (16 and under) to Court before a plea can be accepted from the minor with certain traffic, alcohol, school, or tobacco offenses.
6. If you fail to respond to this charge by the appearance date shown on the citation, an additional charge of violation of written promise to appear may be filed against you. Warrants for your arrest may be issued. There are additional fees added to the Court costs and fines, and a hold will be placed on your driver’s license.
7. To Remedy your citation by taking a DRIVER SAFETY COURSE: The Court must receive your signed and notarized affidavit for Driving Safety Course, which can be obtained on our webpage or at our office, as well as a copy of your current Texas Driver License and proof of current liability insurance. The fee payable to the court will be \$110.00 due with your Affidavit. If you have a COMMERCIAL DRIVER LICENSE currently or at the time the citation was issued, you will not be allowed to take a driving safety course. If you are charged with speeding at either **SPEEDS OF 95 M.P.H. or more or 25 M.P.H. or more above the speed limit**, you will not be allowed to take a driving safety course.
