1. **REVIEW OF MINUTES:** To review and discuss the Minutes of the last meeting held January 26, 2021 and take appropriate action.
2. **CORRESPONDENCE:** To receive, review and discuss correspondence to the Randall County Bail Bond Board.
  - A. Received \$2,200 of additional collateral from Bail Bonds by Judy on 2/3/21. Their limit has been increased by the SO accordingly.

  - A. Discuss and take action on the following amendment to the Rules and Regulations of the Randall County Bail Bond Board:
    - 5.1 Bonds shall be made under the following regulations;
      - f. A bail bond surety may, at any time, by posting additional security, increase the bail bond surety's limit.
        - (1) The County Treasurer may accept cash, assignment of a certificate of deposit or a cashier's check without further Board action. The minimum amount of security that can be given at any one time, through December 31, 2021, is \$1,000.00. Thereafter, the minimum amount shall be increased to \$2,500.00.
